#### ICD - 10 - Learn, Review, Do! 2020 ICD-10-CM Diagnosis Code Updates and Clinical Coding Requirements

There are 273 proposed code additions, 30 revised codes and 21 invalidated codes set to take effect on October 1, 2019. Accurate diagnosis coding of new and chronic conditions pose a challenge for coders, who are often confused on when and what to report -- especially with new and deleted codes each year. With each change, the complexity of documentation requirements changes as well. This workshop will cover code and guideline additions, deletions and revisions for FY 2020 ICD-10 -CM coding. Additionally, clinical documentation requirements for new codes and chronic conditions will be presented. Participants are encouraged to bring coding manuals for added practice (not required) during interactive activities.

#### CMS FY 2020 Proposed Changes and NCCI Edit/Modifier Use Updates Medicare Physician Fee Schedule and Evaluation and Management Coding for CY 2020

The Centers for Medicare & Medicaid Services (CMS) has issued a proposed rule that would update physician fee schedule rates by 0.14% in calendar year 2020. CMS also proposes changes for evaluation and management (E/M) services, specifically, it would revert back to setting separate payment rates for all five levels of E/M visits rather than blending payment rates for certain levels (as it finalized last year). An in-depth discussion regarding these proposed changes as well as others including: physician, non-physician, and medical team medical record documentation standards; several rules related to billing and payment for care management services; chronic care management services, updates to the Merit-based Incentive Payment System (MIPS) for the CY 2020 reporting period, and several provisions related to treatment of opioid use disorder treatment, counseling and payment.
